

REACH

Information on the regulation EC No. 1907/2006 for the Registration, Evaluation, Authorisation and Restriction of Chemicals (= REACH).

The REACH regulation requires that all chemical substances produced in quantities of more than one tonne per year are pre-registered or registered before they can be approved for distribution in the European Union.

Intercable SRL does not produce any chemical substances.

We only sell products which are defined in a chemical-legal sense as "products" and not as "substances" or "preparations", in accordance to article 3 / paragraph 13: "Definitions". According to the requirements of the REACH Regulation, Intercable is a downstream user and therefore not subject to REACH registration requirements.

Furthermore, we can also confirm, to the best of our knowledge, that no products manufactured by Intercable contain substances in concentrations that exceed the permitted limit values laid down by "[ECHA](#)" (European Chemicals Agency) in its so-called "[Candidate list](#)" of Substances of Very High Concern ([SVHC](#)) / last Candidate List update in june 2018.
